RENT: A reminder to all. Rent for the site in which you occupy is due on or before your due date. A late fee of 50.00 will be added if rent does not reach our office buy the actual lease date.

Electricty: The electricity for the campground is paid by Pioneer Family Campground and then billed to the tenants. The amount of lost money and or outstanding electric at this time is unacceptable. We will adding a 25.00 per month late fee and implementing the policy that electricity to your site will be turned off and a lock placed on meter until the bill is paid. There are many who still owe for the electric billed and we are asking that you forward payment asap. NON PAYMENT OF ELECTIRC WILL BE GROUNDS FOR NON RENEWAL OF LEASE

**Dumpsters:** We can't say this enough, it is mentioned every year and still we are having issues. Trash ONLY is permitted in these containers. The billing for this service is based on weight and if the cost continues to rise we will continue to pass on the cost. Lumber, furniture, grills and appliances do not belong in the dumpsters. If you have items of this nature please get with Keith or Kim or Michael and we will be glad to tell you where you may put them as we have a Scrap Gentleman that will pick them up. If you make a purchase that comes in a large box then please take the time to break it down. If these items are found in the dumpster and we know who it belongs to it will be delivered back to your site.

**Golf Carts**: 5 MPH people at all times. It is very rude to fly down dusty roads when there are people trying to eat meals outside or are following behind you. Also there are many children in our park and their safety is a concern and they tend to be too busy playing to look before they dart into the road. **VEHICLES**: The 5MPH also applies to all cars, trucks and motorcycles.
